



RULES AND REGULATIONS

BEFORE YOU STAY AT THIS CAMPSITE, PLEASE READ THE RULES THAT WILL HAVE TO BE COMPLIED WITH. ENTRY INTO THE CAMPSITE IS ACCEPTANCE OF THESE RULES WITHOUT RESERVATION ON THE PART OF THE CUSTOMER.

Art. 1 * Camping Access *

Any person and for any reason who intends to access the campsite must be provided with the management's authorisation.

- a) For this purpose, the identity documents for the legal records must be presented to the Directorate.
- b) The entry of minors not accompanied by an adult, who is legally responsible, is not permitted.
- c) Access to and camping presence of unauthorised persons shall entail:
 - Violation of the Public safety Regulation (art. 109 TULPS);
 - Violation of art. 614 C.P. (trespassing);
 - Violation of art. 633 C.P. (Invasion of land and buildings);
 - Violation of art. 624 C.P. (service theft);
 - Crime of fraud.

Art. 2 * Minimum stay *

- a) The minimum stay camping from 10 to 20 August is 7 days.

Art. 3 * Registration *

- a) The customer is required to check the accuracy of registration, to indicate to the director discrepancies and to notify changes in advance, such as the change of pitch, arrival and departure of guests.

Art. 4 * Choice and use of pitches *

- a) The pitch can be chosen by the customer, taking into account the direction of staff.
- b) The pitches to be booked can only be occupied after authorisation by the management.
- c) Cars must be parked on their own pitch. If this is not possible, they must be parked in the area indicated by the director. Never on another pitch. The owner of the car parked on another pitch will be charged the daily fee of the pitch. All vehicles can only be used to enter and exit the campsite during the permitted hours (08:00 -13:00 / 16:00 – 23:00) at a walking pace and with respect.

Art. 5 *Departure Time *

- a) If the departure does not occur within the daily deadline (by 12.00 hours), the customer will be required to pay the stay on the day of departure.

Art. 6 * Daily Guests - Visitors *

- a) The management reserves the right to allow the entry of daily visitors and guests with free short-term permission (1 hour), compatibly with the organisational needs of the campsite. Excluded from 10th to 20th August.
- b) A subsequent extension of stay must be authorised by the management and involves the payment of the stay according to the price list.
- c) Visitors can only enter the campsite on foot and during the scheduled day (08:00 – 20:00).
- d) The campsite customer is required to ensure that their guests are in possession of the management's authorisation, and is responsible for their behaviour within the campsite.

Art. 7 * Animals *

- a) Dogs must be kept on a leash and exercised outside the campsite for their physiological needs.
- b) The owners are responsible for any damage caused by their animals.
- c) Dogs are not allowed on the beach. (Port Authority Ordinance).

Art. 8 * quietness and Silence *

- a) At any time, actions, activities, games and the use of equipment that cause disturbance to guests of the complex must be avoided.
- b) In particular, arrivals and departures during the quiet hours are not allowed (see timetables); -The movement of motor vehicles, - The use of sound equipment; - Mounting and disassembling tents.

Art. 9 * Beach *

- a) The camping village beach is divided into two sectors:
 - 1) Equipped private beach: Only umbrellas and sunbeds owned by the campsite are permitted. The use personal umbrellas in this area is forbidden
 - 2) Free private beach: Available to guests of the campsite.
- b) Boats have their disposal an area reserved to them.

Art. 10 * Children *

- a) Parents are responsible for the behaviour of their children, whose liveliness, education and need cannot be to the detriment of the quiet, safety and hygiene of other guests.

Art. 11 * various bans *

It is prohibited to:

- a) dig into the ground holes or channels.
- b) light open fires.
- c) discard waste outside the appropriate containers.
- d) damage the vegetation.
- e) pour oils, fuels, hot liquids, salted or waste liquids on the ground.
- f) wash cars or other vehicles in the campsite.
- g) wash dishes and linens outside the appropriate sinks.
- h) wash or wash at the campsite fountains.
- i) wasting or misusing water.
- j) roll out fences, shading tarpaulins, wire or anchor anything to the plants, pull ropes at normal head height and install anything else that could constitute potential danger or be in the way of free passage.
- k) turn on marine engines and set up windsurfers and kitesurf near the shore.

Art. 12 * Lost Property *

- a) objects found in the campsite must be handed in to the management as prescribed by law.

Art. 13 * Alerts *

- a) telephone communications, correspondence and calls to guests must be authorised Article 13 of EU Regulation 2016/679 (GDPR) and Legislative Decree 196/2003 and s.m.i.

Art. 14 * Liability *

- a) The use of sports and leisure equipment takes place at the user's own risk.
- b) Also the management is not responsible for:
 - Theft of objects and valuables not entrusted and accepted in custody for safekeeping. A safekeeping service for valuables is available to customers where money, valuables and documents can be deposited.
 - Damage caused by other guests, by force majeure, by natural disasters, by insects, by diseases and epidemics, including plants or other causes not dependent on the negligence of the camp staff.

Art. 15 * Expulsion *

The management reserves the right to evict and inform the relevant authorities of those who, in its judgment, are in contravention of the regulation or, however, disturbing the harmony and the spirit of the receptive settlement:

- a) damage the good performance of community life and the interests of the receptive complex.
- b) are found to be in a state of mental confusion because of drink or drug use.
- c) criminal damage, destruction to property or injury to persons.

THE RIGHT TO RESERVE A PITCH FOR THE FOLLOWING YEAR EXPIRES ON 31ST MARCH. AFTER THAT DATE, THE DIRECTOR WILL BE FREE TO ASSIGN THE PITCH TO ANOTHER. THE ACT OF ENTRY INTO THE CAMPSITE IS ACCEPTANCE WITHOUT RESERVATION ON THE PART OF THE CUSTOMER.
